Sanibel Friends: The state of Florida has until October of this year to exercise an option to purchase 26,000 acres of U.S. Sugar land south of Lake Okeechobee -- lands critical to Everglades restoration and the preservation of our estuary.

But funding must be approved by the state legislature before its current session ends on May 1st. We have only until May 1st to persuade the legislature to approve the funding.

Urgent Message from The Everglades Trust

Did you know that 1 in 3 Floridians get their drinking water from the Everglades?

We have an opportunity to protect our drinking water for future generations, but our elected leaders must act now. On May 1st, the legislative session will end. If the legislature does not allow the use of voter approved funds to buy land to be used to store and clean drinking water south of Lake Okeechobee, we could lose our last chance to save Florida's drinking water and the Everglades.

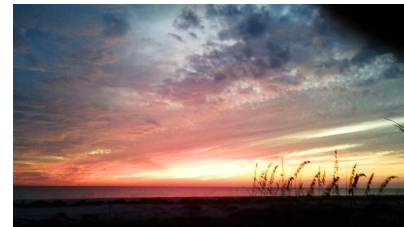
